5th Assises de la coopération décentralisée - Regions and Cities for Development - Brussels, 10-11 July 2017

On 10 & 11 July 2017 the European Committee of the Regions and the Commission organise the 5th Assises de la coopération décentralisée. More than 600 participants, Local and Regional Authorities from the EU, Africa, Caribbean, Pacific and Latin America will come together to discuss common challenges and build sustainable partnerships for cooperation to development. News from the EU

The new European Consensus on Development - EU and Member States sign joint strategy to eradicate poverty

The European Union and its Member States signed on 7 June a strategic blueprint, outlining the future of European development policy. This "New European Consensus on Development" represents a new collective vision and plan of action to eradicate poverty and achieve sustainable development.

The jointly developed strategy, in the form of a Joint Statement, was signed during the annual two-day European Development Days by the Prime Minister of Malta, Joseph **Muscat**, on behalf of the Council and Member States, the President of the European Commission, Jean-Claude **Juncker**, the High Representative/Vice President, Federica **Mogherini**, and the President of the European Parliament, Antonio **Tajani**.

The new European Consensus on Development constitutes a comprehensive common framework for European development cooperation. For the first time, it applies in its entirety to all European Union Institutions and all Member States, which commit to work more closely together.

The new Consensus strongly reaffirms that poverty eradication remains the primary objective of European development policy. It fully integrates the economic, social and environmental dimensions of sustainable development. In doing so, it aligns European development action with the 2030 Agenda for Sustainable Development which is also a cross-cutting dimension for the EU Global Strategy.

European leaders committed to three areas:

- They recognise the **strong interlinkages** between the different elements of such action. This includes development and peace and security, humanitarian aid, migration, environment and climate, as well as cross cutting-elements, such as: youth; gender equality; mobility and migration; sustainable energy and climate change; investment and trade; good governance, democracy, the rule of law and human rights; innovative engagement with more advanced developing countries; and mobilising and using domestic resources.

- The new Consensus furthermore takes a comprehensive approach to means of implementation, **combining traditional development aid with other resources**, as well as sound policies and a strengthened approach to policy coherence, recalling that EU development cooperation always has to be seen in the context of Europe's partner countries' own efforts. The Consensus provides the basis for the EU and its Member States to engage in more innovative forms of development financing, leveraging private sector investments and mobilising additional domestic resources for development.
- The EU and its Member States will create **better-tailored partnerships** with a broader range of stakeholders, including civil society, and partner countries at all stages of development. They will further improve their implementation on the ground by working better together and taking into account their respective comparative advantages.

EU proposes enhanced partnership with Africa on peace and security, and job creation for youth

The European Commission and the High Representative / Vice-President presented on 4 May a revitalised framework for joint action, to build a stronger strategic partnership between Europe and Africa for more prosperity and stability in the two continents. The Communication presents innovative proposals in a number of key areas - such as peace and security, migration, job creation or energy - based on priorities defined by African countries and stepping up the existing fruitful cooperation between the two continents. This comes ahead of the Africa-EU Summit in November this year, which will put a specific focus on youth.

The EU proposal identifies three objectives for building an EU-Africa alliance to address common global and regional challenges:

- a **stronger mutual engagement and increased cooperation** bilaterally and in the international arena, based on common values and shared interests,
- **security**, on land and on sea, and the **fight against transnational threats**,
- **sustainable and inclusive economic development** in Africa, in order to create the jobs that the continent needs.

Concrete actions are proposed around two main strands.

The first one aims to achieve **more resilient states and societies**, through closer cooperation and action in order to prevent conflicts, improve conflict management, strengthen governance systems, and manage migration and mobility.

The second strand will aim to **create more and better jobs, especially for youth**. It develops concrete proposals for attracting responsible and sustainable investment, for example with the recently proposed External Investment Plan, which is expected to leverage up to €44 billion of private investment. Further proposals concern the cooperation in renewable energy, agriculture, agribusiness and the blue economy as well as advancement of knowledge and skills. For example, the Commission proposes to launch an African Youth Facility, which will expand the scope of Erasmus+, or to support digital innovation in Africa.

The Joint Communication will now be presented to the Council and the European Parliament.

Rain Water Harvesting (RWH) Tanks over 60% completed by May

By May 2017, 65% of RWH tanks, built with Councils' communities, on a voluntary basis, were completed - a fair achievement - thanks to the Mayors.

The RWH Tanks Project, originally implemented by the MPW&U, involved private contractors that set up the water tanks on the outer islands. When the deadline for the completion of the project came about, many water tanks were still unfinished.

Not wanting the funds to be returned to the donor, the Chief of UNICEF in Kiribati, Mr. Cromwell Bacareza, working through KiLGA, got the consent of Mayors from 13 Councils to collect a share of the RWH tanks, with building materials such as cement, timber and iron roofing, to construct them in selected communities. The communities' contribution was their free labour and local materials such as gravel.

"I am happy with the communities that have completed their tanks, as they have clean rain water for their use that will improve the health and well-being of their children," commented the UNICEF chief.

However, some Councils were not able to complete their systems, even after being allowed extended deadline; so the tanks may have to be moved to schools or other communities that can complete them.

One of the contributing factors to the delays include the lack of materials provided for the systems, as some were short-handed or misplaced.

The best practice here is the fact that many communities were able to complete their tanks by freely giving their labour and local resources. This excellent attitude and practice needs to be encouraged since it allows for greater ownership of the projects, thus making them more sustainable.

One notable indicator of the usefulness of the tanks is the tell-tale footprints that have cut distinctive foot-paths to the taps of the completed RWH tanks for water collection. Many of these are children's foot-prints.
